

Introduction:

This report provides the latest key information from Devon Home Choice and covers 1st April 2018 to 31st March 2019.

Households registered with Devon Home Choice:

In the year to 31 March 2019, there has been an increase in the total amount of applicants placed in Band A - D by 8% (from 16,175 applicants to 17,516 applicants). The overall percentage of applications in Band E rose from 37% to 38%.

The proportion of households in housing need in Band B reduced from 20% in April 2018 to 16% in April 2019, whilst the proportion in Band D increased from 49% to 54%.

Across Devon, the proportion of households in housing need in Band B ranged from 13% in Mid Devon to 23% in South Hams. The proportion of households in housing need in Band D ranged from 40% in Teignbridge to 57% in Mid Devon and North Devon.

Note: The percentages given for Bands A-D refer to the proportion of households in housing need who are in that Band (e.g. 16% of all households in housing need across Devon are in Band B). The percentage given for Band E refers to the proportion of households in Band E of all those registered (e.g. 38% of households registered across Devon are in Band E).

Table 2 below shows the change in numbers on the register by local authority between 3rdApril 2018 and 7th April 2019. Four local authorities (Mid Devon, North Devon, Torbay and Torridge) saw a reduction in the number of households in housing need over the year, whilst the other six local authorities saw an increase.

One bedroom properties remains the greatest need across all local authority areas, (Table 3) with 57% of applicants requiring a one bedroom home.

Table 4 below shows the numbers on the register in housing need (Band A - D) in each local authority area by quarter. Compared to the previous quarter, there has been a decrease in the number of households in housing need (Bands A - D) by 8% from 19,029 applicants to 17,516. The reduction in numbers is the result of renewals being carried out by a number of local authorities. The reductions range from less than 1% in Teignbridge and Torridge to 27% in North Devon. There were increases in numbers within 3 local authority area ranging from 1% in West Devon to 4% in Torbay.



Chart 1 shows the number of households in housing need by local authority, using January 2017 as the base year. The Chart highlights some significant differences between local authorities. For example, whilst the number of households in housing need has significantly decreased in South Hams, Torbay and North Devon between January 2017 and April 2019, East Devon and Plymouth has seen increase of 38% and 33% respectively.

Tables 5a, 5b and 5c below show the percentages on the register and percentages of homes let by the ethnicity of the main applicant for each local authority area and Devonwide. The figures have been rounded to 2 decimal places for clarity, so some may



appear not to add up correctly. A full breakdown of figures can be provided if requested. The percentage of homes let to non-white British households closely correlates to the proportions on the register in all areas with the greatest variance being 2.79% in West Devon.



Bidding Patterns

Table 6 and Charts 3 & 4 below show the number of bids placed in each month in the last two financial years (April 2017 until March 2018 and April 2018 until March 2019). This also includes the number of households who have placed at least one bid in each month. January 2019 saw the highest number of bids (32,428), yet March 2019 saw the highest number of bidders (6,990) since we started recording these figures.

Comparing the figures from both financial years, there has been an increase in the average amount of bids and bidders each month. The average number of bids for the 2017/18 financial year was 21,323 whereas the average number for the 2018/19 financial year was 25,716, an increase of 21%. The average number of bidders for the 2017/18 financial year was 5,173 whereas the average number for the 2018/19 financial year was 6,066, and increase of 17%.


To date 5,883 (3,917 of which are active) applicants have set up a total of 8,807 property alerts. This is an increase of 1,582 from the previous quarter (21% increase) and an increase of 6,579 from April 2018 (295% increase).

Chart 3: Numbers of bids by month (including trend line)








Chart 4: Numbers of bidders by month (including trend line):

Table 7 below shows the proportion of applicants by local authority and Band who are considered to be inactive (e.g. they have not logged in or bid during the last 6 months and are not on autobid).

The proportion of inactive applicants has reduced since April 2018 across all bands, the largest of which being a reduction 6% for inactive applicants in Band C. The figures range from 28% in Teignbridge to 58% in East Devon and Plymouth, with the total amount of inactive applications reducing from 54% to 51%.






Chart 6: Average number of bids for sheltered homes

Homes let:

4,009 general need homes were let from 1st April 2018 to 31st March 2019 (Table 11). The proportion of general needs homes let to applicants in Band B during 2018/19 was 44%. This is down from the figure of 50% in 2017/18.

There is a significant range between the proportions of general need properties let to households in Band B between local authorities – from 26% in West Devon to 55% in North Devon and Torbay.

It should be noted that the proportion of homes lets to households in Band B may be affected by the higher number of homes that require a local connection in some local authority areas.



589 sheltered homes were let from the 1st April 2018 to 31st March 2019 (Table 13). The proportion of sheltered properties let to applicants in Band B in 2017/18 and 2018/19 has remained the same at 42%. Once again, there is a vast range in the proportion of sheltered properties let to applicants in Band B between the local authorities in Devon, ranging from 17% in West Devon to 63% in East Devon. However, one thing affecting



the results shown is that some properties that are advertised on Devon Home Choice with age restrictions are not advertised as sheltered.




Over 39,000 homes have now been let through Devon Home Choice since 2010. The total number of lets per year by bedroom by bedroom size is shown in Table 15 and Chart 9 below. 


